THE KFFA ORGANIZATIONAL STRUCTURE ENSURES CORPORATE GOVERNANCE AND OPERATIONAL FLEXIBILITY:



- **KFFA Conference – the highest governing body:**
 - defines goals and objectives, accepts programs
 - establishes a system of contributions, etc.
- **The Supervisory Board:**
 - coordinates the decisions of KFFA Executive Directorate
 - controls the work of KFFA Executive Directorate
 - decides on membership in the KFFA
- **KFFA Honorary Chairman of the Supervisory Board of ANEK – I.Segal**
- **KFFA Chairman of the Supervisory Board – E.Zhakishev**
- **KFFA Executive Directorate, headed by the General Director – Nurtazin A.K.:**
 - ensures the implementation of decisions taken
 - takes measures to develop the market and protect the interests of KFFA members,
 - consults, informs, accepts applications for membership, etc.
- **KFFA audit Commission:** controls the financial and economic activities of the association

TWO TYPES OF KFFA MEMBERSHIP : **active and associate**

■ **KFFA Activ members have the right to :**

- vote in decision-making
- elect and be elected to governing bodies
- receive a recommendation for joining FIATA





TWO TYPES OF KFFA MEMBERSHIP : **active and associate**

- **KFFA associate members have the right to:** an advisory vote in decision-making
- **All KFFA members have the right to:**
 - make proposals for the consideration of problematic issues, implementation of projects
 - participate in discussions;
 - receive up-to-date information, have access to all pages of the [KFFA website](http://www.kffanek.kz)
 - post information about the company on the website under agreed terms, etc.;

- notarized copies:
 - Charter of the enterprise
 - Company registration certificate
 - Fill out the agreement with ANEK

- for active membership additionally required: copies of two recommendations of [KFFA Active members](#)
